Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -  
第 52(1) 條 / Section 52(1)  
在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5% 的臨時訂金。  
A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.  
第 53(2) 條 / Section 53(2)  
如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。  
If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.  
第 53(3) 條 / Section 53(3)  
如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。  
If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

買方於簽署臨時買賣合約時須繳付相等於樓價 5%之金額作為臨時訂金。其中港幣\$100,000 之部分臨時訂金須以相關指明住宅物業適用的銷售安排資料列明之繳付方法以銀行本票或支票繳付，臨時訂金餘額可以本票或支票支付，本票及支票抬頭請寫「的近律師行」。

Upon signing of the Preliminary Agreement for Sale and Purchase, purchasers shall pay the preliminary deposit equivalent to 5% of the purchase price. HK\$100,000 being part of the preliminary deposit must be paid by cashier order(s) or cheque(s) pursuant to the payment method(s) listed in the Information on Sales Arrangements in respect of the relevant specified residential property(ies), and the balance of the preliminary deposit may be paid by cashier order(s) or cheque(s). The cashier order(s) and cheque(s) should be made payable to “DEACONS”.

**(A) 120 天現金優惠付款計劃 120-day Cash Payment Plan (照售價減 5%) (5% discount from the Price)**

- (1) 買方須於簽署臨時買賣合約（「臨時合約」）時繳付相等於成交金額 5%作為臨時訂金。買方須於簽署臨時合約後 5 個工作日內簽署正式買賣合約（「正式合約」）。

The purchaser(s) shall pay the preliminary deposit equivalent to 5% of the Transaction Price upon signing of the preliminary Agreement for Sale and Purchase (“PASP”). The formal Agreement for Sale & Purchase (“ASP”) shall be signed by the purchaser(s) within 5 working days after signing of the PASP.

- (2) 成交金額 95%即成交金額之餘款於買方簽署臨時合約後 120 天內由買方繳付或於賣方就其有能力將物業有效地轉讓予買方一事向買方發出通知的日期後的 14 天內支付，以較早者為準。

The terms and conditions and the approval or disapproval of applications for the First Mortgage Loan are subject to the final decision of the Referred First Mortgagee, and are not related to the Vendor (who shall under no circumstances be responsible therefor). No representation, undertaking or warranty, whether express or implied, is given, or shall be deemed to have been given by the Vendor in respect of the terms and conditions and the approval or disapproval of applications for the First Mortgage Loan. No matter the First Mortgage Loan is granted or not, the Purchaser shall complete the sale and purchase and pay the balance of the Transaction Price in accordance with the agreement for sale and purchase. The Purchaser shall have no claim whatsoever against the Vendor as a result of or in connection with the approval or disapproval of the First Mortgage Loan and/or any matters relating to the First Mortgage Loan.

The “Ad Valorem Stamp Duty Benefit” is only a subsidy offered by the Vendor and the Vendor will under no circumstances be liable for any delay in offering the “Ad Valorem Stamp Duty Benefit” or be responsible for any penalty or loss if there is any late payment of the “Ad Valorem Stamp Duty Benefit” (or any part thereof) for whatever reason. This benefit is subject to other terms and conditions.
